Treasurer's Report:

We are ending the year on a very good note. We are underspent by \$21,000 and raised over \$30,000 of what we budgeted for the year.

There were \$10,000 left over on the enrichment budget due to some programs not being offered this year.

We discussed the possibility of assigning some funds to principals for school spending. Mr Wiltshire thought they could really use that for a new sound system and other needed items.
